

Mitch McConnell and Elizabeth Warren Filibuster

If you follow the news or tune in on your local radio station, you probably would have heard the word "filibuster" thrown around recently, especially from the past two months. Most simplistically, the filibuster is described as by Google, "An action such as a prolonged speech that obstructs progress in a legislative assembly while not technically contravening the required procedures." Currently, it is often used as a way to block a vote on a bill. A ratio of 60:40 must be needed in order to advance said bill.

Recently, there has been a great debate regarding the passing ratio which is based on the even larger argument on the existence of universal background check-something that is believed to be best for the safety of America. Two important people have rose as the figureheads for this flaming subject: Senator and Presidential Candidate Elizabeth Warand Senator Mitch McConnell.

Senator Elizabeth Warren (Democrat) strongly supports the idea of a universal background check. She voiced her reasons for thinking this during the debate on Thursday night, the twelfth, by stating that we have a, "...Congress

that is beholden to the gun industry... And unless we're willing to address that head-on and roll back the filibuster, we're not going to get anything done on guns." She is supported by mostly Democrats. Even though the Democrats had the majority at 54 votes, they were still six short of getting the bill passed. As a result of this failure, they believe that the ratio should be pushed down to 51:49 to be able to move quickly from not only the bill on universal background checks, but also different bills.

The opposing side, represented by Senator Mitch McConnell and composed of mostly Republicans, argues against this as it would be compromising towards both tradition and the rights of the minority. This side believes that to simply reduce the ratio down to winning just the majority would destroy the very foundation America stood upon: the foundation in which no majority could take advantage of the minority. McConnell writes in his article published in the New York Times, "If future Democrats shortsightedly decide to reduce the Senate to majority rule, we'll have lost a key safeguard of American government."

Special Election in North Carolina District 9

Congressional District of south -central North Carolina made national headlines when a special election was held to fill the vacant seat for their House representative. While decidedly an unusual situation, it was the circumstances surrounding the election that made it nationally significant.

In November 2018, the 9th district election finished in a narrow margin of 49.25% to 48.93%, with Republican Mark Harris set to serve in the 116th House of Representatives. During his campaign, Harris, an

On the 10th, the small 9th evangelical minister turned politician, received support from the President and vice-President, while his opponent, Dan McCready, also enjoyed support from strengthening Democratic Party in North Carolina. Harris's victory over McCready by only 905 votes was a significant challenge to a traditionally Republican seat. However, when the district election managers were asked to recertify the tally of the close election, they re-

Government to End Medical Deferred Action

story with lifethreatening consequences has been developing since August 7, 2019, and has caused great concern among Americans. The series of events that make up this story starts with the sudden end of the government program called Medical Deferred Action. Although the program isn't very big, it is responsible for saving the lives of immigrant children with fetal diseases. The program works through an application process in which immigrants who are receiving treatment for life threatening illnesses make their cases for staying in the country.

In August, U.S. Citizenship Immigration and Services (USCIS) sent out letters to those families who were in the program saying that they will no longer be offering Medical Deferred Action. The letter threatened to take legal action if the recipient and their family did not leave the country within 33 days. After the news broke of the letters being sent, the USCIS released a statement saying that the medical deferred action requests are now being submitted to ICE. This switch in policy was not announced by the government, nor was it explained in the letters sent. ICE, the U.S. Immigration and Customs Enforcement, addressed the statement by explaining that ICE will review the cases and determine the status of the applicants. Even after the explanation given by two agencies, legal experts find the situation peculiar, with normally qualified applicants being turned down and still told that the medical deferred action is not being considered.

It was later noted that an internal memo had been circulated from a top Trump immigration official saying that the USCIS should no longer delay deportations of undocumented immigrants who are recieving medical treatments. The memo suggests that in actuality, ICE will not accept any requests for deferred action. The deferred action for medical reasons is available for cases made through the U.S. Department of Homeland Security (DHS) for military members and their families.

Responses to the new policy came from families who are affected by it, concerned citizens, legal advocates, and U.S. senators. Many of those who spoke out make the argument that the change in policy is inhumane and cruel. Sending back children and their families with fatal illnesses has been called a "death sentence", since many of the children who were under medical deferred action do not have the kind of treatment necessary to keep them alive in their home countries.

One organization called the Irish International Immigrant Center (IIIC), which is dedicated to serving Irish immigrants and others from around the world, has clients who are under the medical deferred action program. One client who is affected by the change in policy is the Sanchez family. Sixteen-

year old Johnathan Sanchez, son of Gary and Mariela Sanchez, was born in Honduras and was born with cystic fibrosis. He was diagnosed when blood samples were sent to the U.S. The family had already lost their daughter to cystic fibrosis at the age of 18. Since there are no specialists in cystic fibrosis in Honduras, the Sanchez family entered the United States in 2016 under a tourist visa. At first they were able to extend their stay, but the treatment was going to last longer than the six month extension, which then led to them applying for medical deferred action. He has been receiving treatments at Boston Children's Hospital. Now, Johnathan Sanchez worries that he may have to go back to Honduras, where he is destined to die.

Massachusetts Senator Edward Markey took a strong position on the issue, calling the policy change by the Trump Administration "the most inhumane of all of Donald Trump's policies." The Mayor of Boston, Marty Walsh, also spoke out about the situation Twitter, saying, "Disregarding immigrants' requests to temporarily remain in the US for life-saving treatment is absurd and inhumane. We stand in support of our health and legal professionals who work tirelessly to eliminate barriers to care."

After weeks of painfully waiting for news on whether the program will be restored, families can now breathe easy because Acting Homeland Security Department Secretary Kevin McAleenan has directed that the USCIS resume the program of medical deferred action for non-military families. Democrats and other activists are the ones who have pushed for the end of this inhumane policy.

A House Oversight committee held a hearing on September 11 on the issue of medical deferred action. The hearing included testimonies from recipients of medical deferred including Johnathan Sanchez. The committee has taken the task of answering questions that are still left to be answered. In his opening statement, Chairman Jamie Raskin said, "But there are still crucial questions left unanswered. Will anyone who applied after August 7th be eligible for relief? Does actually plan to grant who have reopened applications? What will happen to families that are currently receiving deferred action, but will need to reapply once their two-year stay expires?" He makes the point that the sudden restoring of the program was done solely for appearance and to avoid further criticism. Maryland Rep. Elijah Cummings also points out that, "It should not take an emergency hearing by Congress — and threats for more — to force the Trump Administration to do the right thing." Although this story is still has not reached its conclusion, one can now sleep better knowing that actions are being taken to solve this nightmare.

New York Plastic Bag Ban Effective 2020

Plastic bags have become a well known threat to the environment. They're found nearly everywhere nowadays. Plastic bags float on the surfaces of streams and lakes. They soar through the wind across quiet streets. They dangle from the branches of trees, waiting to be freed. Plastic bags even hide in places you can't see them, such as the stomachs of unsuspecting, hungry animals.

It is estimated that about a trillion plastic bags are used annually across the globe. In New York State alone, 23 billion are used a year. New York has the fourth largest population in the United States, home to about 20 million residents as of 2018. That's a lot of people to contribute to this environmental problem.

New York State Governor, Andrew M Cuomo, signed a legislation on Earth Day 2019 to ban single-use plastic bags. Starting in March 2020, plastic bags that are non-biodegradable cannot be sold by retailers. This is a big step to help the environment, ending greenhouse emissions released in the production of plastic bags, and protecting marine life from an unpleasant death.

Stores, restaurants, and any other retailer will not be permitted to provide customers with plastic bags. However, New York counties can opt to sell paper bags instead for a 0.05 cent fee. The fee will go toward the Environment Protection Fund, which will use the money to make reusable bags more accessible. While paper bags tear easily and aren't easy to reuse, they have a much less significant effect on the environment.

Not all plastic bags will be banned. Trash bags, bags for holding specific foods, and garment bags are exempt from the ban.

Although many praise the idea of banning plastic bags, there are also many critics. Plenty of retailers across the state are unhappy with the future changes. Plastic is convenient and cheap, making plastic bags the go-to option for those looking for a profit.

Many also claim the law is too vague, especially with the edits and changes it has had. Critics have stated that the definition of a plastic bag is too general. Retailers are unsure of what is considered to be reusable. Retailers are unsure how to apply the upcoming law while still making customers happy.

Some customers themselves

aren't excited about the news. Many believe plastic bags have many uses, including being used as trash bags. Some say they never put plastic bags to waste, and that not all New Yorkers should be punished for the bad deeds of a few. Some New Yorkers are really attached to their plastic bags.

Whether or not you agree with the ban, it is a well known fact that plastic bags have plagued our environment. As of now, only 1 in 20 plastic bags are recycled properly worldwide. Reduction of plastic bags helps to lead New York towards saving marine life and cleaning up the Earth. Switching to reusable bags may be more expensive for retailers, but a planet covered in plastic bags would be more costly.

ther counts prompted an investigation by the North Carolina Board of Elections into the campaign. They alleged an elaborate scheme of tampering with absentee ballots carried out by Leslie Dowless, a Harris campaign-affiliated official. Dowless was indicted on several counts for tampering with mail-in ballots (votes not taken at a polling center and mailed in by those unwilling or unable to vote at the location) to favor Harris. In the midst of this controversy, the Board voted to hold another election to fill the seat, now vacant, while Harris announced the cession of his position as a candidate.

This scandal set the stage for the late 2019 special election closing the 2018 midterms. Dan McCready ran again as the

Democratic candidate, while state senator Dan Bishop filled Harris's spot as the Republican nominee. The opposite positions of these two candidates also attracted national attention as a microcosm of partisan policy disagreements.

Dan McCready notably showed strong opposition to gerrymandering. On the 13th, new NC Senate and House district lines were approved to replace some old ones, which were ruled in a court case to be unconstitutionally drawn. "Gerrymandered" districts are said to be drawn to favor one party over another via exploiting regional political majorities. This practice fails to acknowledge the mixed political beliefs of larger communities within a state as a whole.

Republican state senator Dan Bishop

was known before the election as the lead writer of a North Carolina anti-LGBT rights bill in 2016 that was later passed into law. HB 2, known as the "bathroom bill", required public bathrooms to only be available to a single "birth certificate gender", disallowing some transitioned individuals from using the restroom of their choice.

The Republican Party and President Trump celebrated Bishop's victory in the election on the 10th over McCready, by a margin of 96,103 to 92,199 (50.73% to 48.67%). Dan Bishop will assume his role as the 9th District's House representative in the 116th session amidst major reforms nationwide and in his own state.

Brexit Turmoil Continues in Britain

Since the United Kingdom voted to leave the European Union three years ago, Britain has been in political turmoil and is on its third prime minister. Britain is no closer to leaving the European Union than at the time of the vote. But due to new developments, including the actions of Britain's new prime minister, Boris Johnson, Britain may finally leave the European Union on October 31st.

After months of extensions on the date that Britain is officially going to leave the European Union under former Prime Minister Theresa May, Johnson wants to leave the European Union on October 31, with or without a deal. On the other hand, Parliament disagrees. In a close vote, Parliament voted to reject a no deal Brexit under any circumstances.

In order to stop any opposition, Johnson suspended Parliament between September 11 and October 14. This has caused a backlash amongst the people of Britain. Lawsuits have ensued as a result. As of September 18, the British Supreme Court will be hearing a

case about the legality of Parliament's suspension by the Prime Minister.

Johnson is committed to a withdrawal from the European Union on October 31, but opposition leaders are working to make sure a no deal Brexit does not happen. Jeremy Corbyn, leader of the opposition Labour Party, wants to make sure a no deal Brexit is off of the negotiating table.

Corbyn then wants to call a general election to try and boost his party's standing in Parliament. Corbyn hopes that Labour will be able to repeat their success in the 2017 general election. But Labour MPs are split over the issue of following through on Brexit or holding a second referendum. Johnson is calling for general elections but refuses to agree to abide by the law passed by Parliament that says a no deal Brexit will not happen, prompting a rejection of elections by Corbyn.

After three long years, there is still no end to Brexit and it remains to be seen whether Britain will indeed exit the European Union on October 31st.

Saudi Arabia Faces Oil Crisis

On September 14th, huge fires broke out at the largest oil processing facility in the world as the Abqaiq oil profacility cessing and Khurais oil field fell victim to drone strikes in the hours before dawn. Now, the US is deploydefense ing military forces to Saudi Arabia as well as accelerating the shipment of military hardware to the kingdom. The Houthi rebels Yemen first claimed responsibility for the attacks, but it later became clear that a country that supports them, Iran, is also involved. Saudi Arabia is in conflict in Yemen as

they try to reinstate the original Yemeni government against the will of the Houthi rebels. The drones were found to have originated from Iran, not Yemen, and Iranian President Hassan Rouhani said Saudi Arabia should see the attack as a warning to end the war in Yemen, while insisting attack came from Yemeni forces.

The greatest fear after the strike was the effect on the global oil market. About five million barrels a day of production was affected for a few days immediately after the strike, and production of oil will be re-

duced by a couple million barrels a day for the future, but overall the oil market will be able to recover quickly because of the vast amounts of oil stored by each country. So if it seems to be an attack targeted at Saudi Arabia, why is the US getting involved? Saudi Arabia requested what the United States Secretary of Defense, Mark Esper, described as "extra defensive support," that will "send a clear message that the United States supports our partners in the region."

Another reason comes from Treasury Secretary Steve

Mnuchin, who told reporters, "We are continuing the maximum pressure campaign." In May, the US withdrew from a 2015 nuclear accord with Iran and implemented sanctions that would sharply accelerate its goal of driving Iran's oil exports to zero. By trying to reduce Iran's oil exports, the US effectively puts a lot of strain on the economy. The Trump administration's hope is to manipulate Iran into agreeing to 12 demands that they must meet before the US lifts sanctions. The list asks Iran to accept new limits on its nuclear program, end ballistic mis-

sile tests, cut off support for US designated terror groups and free US citizens held in detention. But, Iran is not having it. Iran's leader, Khameni, tweeted that the US should return to the nuclear deal if they want to negotiate, otherwise, "no negotiation will take place between Islamic Republic and US officials at any level." After the national security meeting on Monday, there is no news of an imminent military attack, and it appears that the US is trying to avoid larger scale border conflict with Iran.

New Bill Affects Uber, Lyft drivers

Dara Khosrowashahi and Logan Green may soon have to rethink their business models. California's Assembly Bill 5 is slated to re-classify "gig economy" workers as employees, potentially affecting the state's 400,000 "gig economy" workers at companies like Uber, Doordash, and Lyft. California Governor Gavin Newsom is expected to sign this bill, which would take effect on New Year's Day of 2020.

Notably, the bill states, "A person providing labor or services for remuneration shall be considered an employee rather than an independent contractor unless the hiring entity demonstrates that the person is free from the control and direction of the hiring entity in connection with the performance of the work, the person performs work that is outside the usual

course of the hiring entity's business, and the person is customarily engaged in an independently established trade, occupation or business." This section is known as the ABC test.


Predictably, management at Doordash, Uber, and Lyft are pledging \$90 million for the purpose of a statewide ballot initiative to exempt their companies from this future law. Yet, this may be to no avail, as the companies would have to demonstrate that the work done by their drivers is not essential to their business model, despite the fact that these companies were basically built on the idea of independent contracting. However, Newsom is willing to compromise with these companies, so as to keep the prices of ride hailing apps down for the general public.

Under this current business model, Uber and other companies do not have to pay their contractors minimum wage or overtime; additionally, there is no requirement to give health care or retirement plans, and payroll taxes do not need to be paid by companies for their contractors. The responsibility for expenses such as the automobile and gas falls on the contractors, cutting costs for these tech companies. This business model can cut operation costs by as much as 20%. This is particularly important for companies like Uber, which has still not become profitable.

Overall, Assembly Bill 5 is sure to create some changes in the economy which could potentially change the future of ride hailing apps as we know them.

Is the DOW Jones Going to Get Out of Limbo?

is a measure of the 30 largest companies in the United States's stocks. Whether there is a recession or recovery going on, the DOW performance often follows the economic state of the United States. For example, during the most recent Great Recession, the DOW lost more than half of its value, or about 53%, from October 2007 to March 2009. From that point to February 2018, a period

like the DOW has been stagnant the entirety of these 19 months. The reality is that the stocks have been more tumultuous than ever before.

Between December 3rd and December 24th of 2018, the DOW fell by about 4,000 points, or a 16% drop. This pushed the DOW back to 22,445 points, the lowest point it was about a year and a half before that point. It would seem logical that the DOW would then either continue dropping or slowly recover from the drop, but that is not at all what happened. In fact, it took just under two months to completely recover these losses, with the DOW growing 17% by early February.

But this growth did not last either. It proceeded to stagnate for three more months until early May when it dropped 1,600 points, or about 7%, over the course of a month. And then what happened? It recovered the losses and then some within a month and a half, with a growth of about 10% at 2,500 points being added.

But of course, this didn't last either. Within another month, the DOW dropped another 1,600 points with a decrease of 7%. And now, with federal interest rates being cut, the DOW is in the process of recovering again, with

growth of about 5% since then between September and Octoof 1,500 points.

And if we go back earlier to late January 2018, when the DOW had reached a high at the time of 26,616 points, it dropped 2,400 points by 9%

What is causing this back and forth shifting? Well, there is certainly a correlation between the US vs China trade war events and the DOW.

There is certainly a correlation between the US vs China trade war events and the DOW. Whenever tariffs are increased or tensions between the two countries appear to escalate, the DOW tends to take a nosedive even if it is in the process of gaining.

over the course of two weeks. And then it stagnated with no end in sight for five months before rallying 1,700 points between July and September 2018, which was when it dropped 2,000 points by 8%

Whenever tariffs are increased or tensions between the two countries appear to escalate, the DOW tends to take a nosedive even if it is in the process of gaining. But whenever there are reports of talks

or negotiations of easing tensions, the DOW will often rally. For example, recently in August this year it was announced that there would be a 15% tariff on Chinese goods. Subsequently, the DOW stagnated during the entirety of the month rather than recover its prior losses from July.

Another factor is US economic reports. Whenever the report or outlook seems to be positive, the DOW tends to rally while a negative report often results in investors pulling out their investments, decreasing the DOW. For example, in late August last year, it was announced that the US economy had yielded a GDP growth of 4.2% in the second quarter, the fastest rate since the third quarter of 2014. And in the following month of September,

the DOW had a positive month where the immediate fallout was a growth of almost 3% with 800 points being added over the course of three weeks.

There are a variety of factors contributing to this DOW stagnation, with no obvious singular factor contributing to most of these drops and rises. It will be very interesting to see how the DOW will perform in the near future.

Charles Mingus—a 40 Year Retrospective

Forty years ago, on January 5th, the world lost one of it's most transcendent, enigmatic, and charismatic musicians, jazz bassist, composer, and bandleader, Charles Mingus. With a career spanning from the early 1940s up until his death in 1979, he has cemented himself in in the development of mid to late 20th century jazz and showed what it could become while being present in numerous corners of the world, from the underground nightclubs in Europe to his apartment in New York City to the stages of Japan, Canada, South America, and numerous other spots of the world.

Born on April 22, 1922, in a military base in Nogales Arizona, Mingus was the son of a mixed father, who was generally half black and half white. This would later

conflict his identity later in his life, making him both black and white (Which at the time meant two distinctly different things), one time stating that he's "Too black to be white, but too white to be black." Mingus grew up his entire youth surrounded by music, primarily gospel music from the church he attended to and mainly the works of jazz giant Duke Ellington. In his early teens, Mingus picked up the cello and learned the instrument for a few years until he came across the bass. Captivated, Mingus dropped cello and picked up the bass and would later get lessons from state orchestral players across the country. Mingus's musical career would soon begin by touring with popular bands with Kid Ory, Lionel Hampton, and the immortal Louis Armstrong.

Mingus would soon find himself in New York City, where he founded the Jazz Workshop, a place where young and inspired musicians can record, learn, and perform their own works alongside with some classics with some of the leading musicians of the 50s. Throughout his career, Mingus would release numerous albums and perform in the productions of many others. Some of his most popular albums are "Pithecanthropus Erectus" (1956), "The Black Saint and the Sinner Lady" (1963), "Mingus At the Bohemia" (1955), and his most popular and notable album, "Mingus Ah Um" (1959).

Like most musicians then and now, his

Stubbornly refusing to reinvent itself after a five-year absence, Borderlands 3 sticks to its guns and manages to outdo itself. You can see exactly three different shirts in total, and at the lowest cost pictured at 299 Robux, translated into real money at the best rate possible (11,000 Robux for 99.99 USD), these shirts are worth about \$2.71. Different groups use the exact same stolen shirts and charge whatever they want, hoping you're not smart enough to use the price sorting tool. You can set the maximum price you're looking for to 5 robux, the lowest you can charge for a single shirt, and see... the exact same issues, but now you're not spending anything upwards of close to 1000 extra Robux (\$9.09 USD) for the same product. At a glance, you might not even be able to see the key difference of the costs being different.

quickly without well-established guidelines, there'd be inappropriate hats everywhere.

While I enjoy the update and potential for new and interesting hats designed by users, there's a lot of other things that I believe need to be fixed first. There are few items available for free in the catalog, just a few simple hats, hairs, and clothing items. On a platform that prides itself on creativity, giving few customization options for free players isn't helping. While free items are given out occasionally, they're usually meant to celebrate a certain event or sponsor. Recent examples that come to mind include a Stranger Things season 3 sponsor and Roblox's 13th birthday, which both featured items that were meant to promote that one event. Usually, they don't fit very well with other items and are oftentimes not very interesting. There's also the rampant issue of bots in the catalog, accounts set up to post the exact same shirt over and over again for profit. Usually, the shirts are unoriginal and have simple names designed to exploit the system and show up once you search a vague. Finally, almost everything in the catalog is stolen content. The system to check for stolen content in the catalog is hilariously bad. This will most likely also be an issue for UGC, assuming that it's possible to use the same parts as others to create a hat that's "inspired" by someone else.

While I'm excited to see what hats can be created by users instead of the admins of Roblox, I believe there are some big issues that need to be addressed first before it can really take off. Creating bot accounts to profit off of hundreds of copies of hats simultaneously and managing the amount of stolen content in the already existing amount of player-created shirts and pants is already a big issue, and if it isn't fixed or improved, new UGC items will most surely fall to the same fate as the shirts and pants sections.



Mortal Kombat 11 was released in April of this year with no hints of additional content. This meaningful weapon variance is further helped along by a greater emphasis on what differentiates each manufacturer. For instance, all Vladof weapons can switch between two firing modes, like a Gatlin gun that toggles to an underslung grenade launcher, while the Children of the Vault weapons don't need to be reloaded at all, but can overheat and need to cool off if you hold down the trigger too long.

But what's most impressive about Borderlands 3's arsenal is how these in-game weapons look and feel when you use them. It's the delightful little touches – like cocking the hammer on a revolver, the red-hot smoking barrel of a shotgun, or a bolt chattering away on an assault rifle – that are the types of details I'd expect to see on handcrafted models, not these procedurally assembled ones. In the same vein, many of the game's weapons feel fantastic with a mouse and keyboard on PC, thanks to pronounced recoil and crisp sound design.

My only minor criticism of the game's gunplay is that the sight picture (the parts of your gun that appear on the screen when you raise it to your eye) on many weapons too often obscure your target, somewhat defeating the purpose of including the ability to aim down sights in the first place.

Then comes the best of all loot: legendaries. Like in Borderlands 2, these guns and gadgets fill out the upper echelon of the loot table with handcrafted effects that are, in many cases, a celebration of how far Borderlands 3 is willing to go to be absurd and surprising. My favorites so far are the Laser-Sploder that spits out rockets and a laser at the same time, the Cloud Kill (Maya, anyone?) which leaves enemies choking on corrosive fumes, and (through what must be the result of a backroom handshake deal between Texas-based developers) the Hellwalker, which is a dead ringer for the Super Shotgun from Doom.

It should come as no surprise that you'll be getting plenty of use out of these guns thanks to a varied and creative horde of enemies. While the familiar menagerie of foes like bandits, skags, spiderants, and more all return with fresh coats of paint, you'll also encounter a handful of new archetypes like the monstrous tink-topped hag or a long shot sniper.

Without giving too much away, you'll also square up against several new enemy types. *Borderlands 3* is at its most hit-or-miss in the quality of its boss encounters, which, frankly, are all over the place. The bulk of them (especially toward the end of the campaign) are particularly good. There's the exemplary Agonizer 9000, who comes complete with crit spots, flaming vents to dodge, a massive saw blade to jump over or slide under, and even a second phase which mixes things up further. And the good news is that every other boss with major plot significance follows this great formula: precise telegraphs,

challenging mechanics, and mostly avoidable damage.

Your adventure doesn't end when the credits roll. Borderlands 3 has several new ways to play, most notably Mayhem Mode, which incrementally ups the difficulty and adds random effects (like Double Whammy which doubles projectiles fired) to some enemies for greater rewards. After unlocking Mayhem Mode you'll also start earning all-new Guardian Ranks which provide further stat increases like gun damage and cool effects like increased loot luck after scoring a kill. Couple this with True Vault Hunter (AKA new game plus), the Circle of Slaughter (horde mode by any other name still smells as sweet), and the all-new Proving Grounds (sort of like a nonrandomized Diablo 3 rift) and there are many enjoyable ways to skin the endgame cat – more than we've seen in any previous Borderlands game.

My Verdict: If Borderlands 3 is what happens when a modern looter shooter doesn't concern itself with the longevity of its item economy and daily quests, then you can sign me up for Borderlands 4 right now. Being untethered from persistent servers and able to trade loot at will is a refreshing change of pace, but that's hardly the only reason why this such an amazing co-op FPS. The sheer magnitude and diversity of its arsenal of fun and surprising weaponry is unmatched, and the striking amount of loving detail and variety packed into its energetic and replayable 30-hour campaign is what makes Borderlands 3 a high-point for the series – and the genre as a whole.

career was fueled with struggle. At one point, in 1962, Mingus faced a tremendous disaster. He held a concert of his jazz band but with a twist, they would perform as if they were in the process of recording a new track. But this wasn't any ordinary track, this was a composition full of virtuosity, a chaotic and captivating piece of music that nobody was prepared for. This was, as Mingus said, his "master symphony," which would later become one of his most famous works. Overall, the concert was a failure, the audience left, none of the musician's were prepared for Mingus's virtuosic and strange parts, and it all crumbled as the performance went on. This devastated Mingus, and would be one of the multiple times that drove him into a depressed state. Mingus wouldn't perform, nor write for many years, in one instance he gave up on music and became a wedding photographer in New

York. In another instance in 1966, Mingus was evicted from his New York apartment and later arrested for suspected drug use after a hypodermic needle was found in his possession. On the day of his arrest, while being escorted out by police, Mingus responded to an interviewer who asked if he believed he was persecuted because he was a jazz musician. Mingus responded, "No, I really think I'm being helped... I don't

know, I think that maybe they just didn't get to see what's going on the so-called 'jazz addition in life.' So maybe this is the police really helping me I don't know."

Nearing the end of his life, Mingus was diagnosed with amyotrophic lateral sclerosis, also known as ALS or Lou Gherig's Disease. As the condition ate away at his body, Mingus lost the virtuosic bass playing you would hear in his earlier tracks. By the time he lost any physical ability in his legs and arms, he would sing and whistle melodies and ideas into a tape recorder that his last of many wives, Sue Mingus, would help record. Charles Mingus succumbed to ALS and passed away peacefully on January 5th, 1979, in Cuernavaca Mexico, his death shocked the world and the musicians that have worked with him for decades.

But what makes Charles Mingus stand out from the crowd besides his associated acts and his life? Well most commonly associated with Mingus is his temper and personality. Most people know Mingus as a hot-headed and incredibly dynamic character. In the words of Mingus's close friend, Gunther Schuller "He could be as calm and as sweet as a two month old baby, and two hours later he could explode like Vesuvius, you know and everything in between." In an eyewitness account, Mingus was performing at a small nightclub in New York City and got into an argument with the pianist and later other players. Mingus reportedly got so furious he put his hand into the piano and ripped out its strings and left the club and performed with another group.

Mingus, asides from his volatile temperament, was also known to have periods of severe depression, from the deaths of his close friends to his previously mentioned failure of a concert, but also very charismatic. His first wife, Celia Mingus Zaentz, spoke about Mingus reading her poetry when they first met. He also wrote compositions for his two separate wives, "Celia" and "Sue's Changes."

But what's mostly overlooked about Mingus is his music and style. Mingus was on the forefront of jazz, avant-garde, and American music all together. His music churns a visceral struggle with limited release, like a bomb that is about to explode, with the only problems being that you cannot disable the bomb, and that the bomb is increasingly getting bigger without any signs of it stopping its growth. World renowned jazz trumpeter Wynton Marsalis describes what Mingus did with music in probably the

most easily understandable way in the documentary "Charles Mingus Triumph of the Underdog," "I feel that he's doing what all the musicians try to do and that is to always reexamine the basic elements, the things that give whatever the particular art form is its greatest power." And its greatest power he gave. During the Civil Rights Movement, two notable compositions of Mingus invoke the emotions of the movement. "It Was a

Lonely Day in Selma Alabama" is a repeated sung chant that is followed by a speedy solo section that returns to the previous melancholy chant. "Fables of Faubus" is a composition in mockery of the governor of Arkansas, Orval Faubus with some of the spoken lyrics being "Oh, Lord, don't let 'em shoot us! Oh, Lord, don't let 'em stab us! Oh, Lord, no more swastikas! Oh, Lord, no more Ku Klux Klan!" Those lyrics can still be heard in some recordings, such as the recording from the Mingus Big Band album "Gunslinging Birds."

Charles Mingus is one of the very few musicians who have made themselves incomparable in any way, in composition, in personality, in appearance, in performance, and in finesse. Charles Mingus was many things, a composer, a band leader, a writer, a lover, a fighter, a caring human, and a volatile one, and a charismatic and enigmatic one as well. At rest, but strained. In your face, but laid back. Sweet, but explosive. Beyond this world, but human. Decades after his peaceful death, after his ashes were spread across the Ganges River in India, his music still lives and breathes. Through various bands such as the Mingus Big Band, Mingus Dynasty, and other large jazz bands that perform his music multiple times. Mingus wrote an autobiography called "Beneath the Underdog" (1971), and in there reads a quote that perfectly sums up Mingus's relationship between himself and music as this year approaches Mingus's 98th birthday this year.

"My music is evidence of my soul's will to live."

Trump and Cuomo Vape Ban

Throughout the last three months, as reports of illness related to vaping have been dominating news headlines, public health advocates have called upon the government to take direct action to curb the vaping epidemic. Although most vaping-related illnesses have been tied to the consumption of vaporized cannabis oils dabs), much of the public discourse around this topic has been focused on nicotine ecigarettes, the use of which has exploded among the teen and young adult populations over the past few years.

On September 11, 2019, the States Secretary United Health and Human Services, Alex Azar, announced Trump administration's intention to ban flavored e-cigarettes and nicotine pods in the coming weeks. In relation to the vaping epidemic, President Trump said "We can't allow people to get sick. And we can't have our kids be so affected." Although tobacco-flavored vape would be allowed to remain on

the market, the Trump administration followed the lead of the state of Michigan and the City of San Francisco to remove sugary flavors like Creme Brulee or Cotton Candy that have especially attracted the youth to nicotine.

On Sunday, September 15th, following the lead of the federal government, New York Governor Andrew Cuomo announced an emergency executive order that would prohibit the sale of e -cigarettes in the state for a period of 90 days after a two week period. This move comes after the New York Legislature raised the nicotine purchase age from 18 to 21.

Although advocates of this policies applaud the Cuomo and Trump administrations for taking action to curb underage vaping, critics claim that this ban will only lead to greater amounts of bootleg vape juice and will cause previous smokers to go back to smoking tobacco which is far more harmful.

iPhone 11 Review

If you are already part of the iOS ecosystem and you want to get an upgrade, the bottom line of this review is this: you should get an iPhone 11. The rest of this article will get into the reasons why.

The iPhone 11 is already seen by many critics as an excellent phone with amazing battery life and a price drop of \$50 from previous year's iPhone XR (\$749). This phone does not have all of the bleeding edge technology that is found on the iPhone 11 Pro, but it manages to cut close to the chase and also would save you a \$300-sized hole in your wallet. Starting off with the display, the iPhone 11 has a 6.1 inch 720p LCD that is almost identical to last year's XR. Scared of Death?

the fear of death may affect much of our decision making, regardless of if we are aware of it or not. A group of three psychologists - Sheldon Solomon, Tom Pyszczynski and Jeff Greenberg - have developed the theory of terror management, inspired by cultural anthropologist Ernest Becker. They've elaborated on the idea that people form mental defenses to avoid the fear of death. To cope with this fear, we usually turn to our culture and belief systems to validate our purpose.

In order to build more evidence for this theory, Solomon, Pyszczynski and Greenberg

It may seem morbid, but have conducted multiple studies, one of which involved a group of municipal court judges. One group acted as a control and the other group filled out a questionnaire asking about their thoughts on their own mortality. Then, they were shown a court case of an alleged prostitute and asked how much bail they would set. The control group gave a standard amount of around \$50, but surprisingly, the other group had set a bail of roughly \$455.

> Another study had people think about mortality or something unpleasant. When they were shown a newspaper article of a citizen stopping a bank

robbery, the control group suggested that the citizen should receive a monetary reward of around \$1,000, while the experimental group averaged over \$3,000. Essentially, when people are confronted with thoughts of mortality, they turn to their beliefs and cultural influences, support those who share similar beliefs, and serve justice on those who differ.

Fear of death also influences our self esteem. A study on Israeli soldiers found that when placed in a driving simulation, while the control group drove at a standard pace, the group that was reminded of death, those whose self esteem

was based on their driving skills ended up driving more recklessly. Another study involved individuals who value basketball, and when reminded of death, they would shoot better at the foul line. And yet another study directed at those who had pride in their strength showed that when they were given something to squeeze and reminded of death, they tended to squeeze harder.

As dark as it may seem, recognizing the concept of mortality may increase your self awareness and help you navigate life with more maturity.


